Utah Conservation Commission (UCC)

- Provide oversight, guidance and support of conservation districts
- The Utah Conservation Commission (UCC) is authorized under Title 4, Chapter 18 of the Utah Code.
 - ▣ The act's Purpose Declaration states that "The Legislature finds and declares that the soil and water resources of this state constitute one of its basic assets and that the preservation of these resources requires planning and programs to ensure the development and utilization of these resources and to protect them from the adverse effects of wind and water erosion, sediment, and sediment related pollutants."
- Created in 1937, this unique state government entity has been active continually since, evolving to meet new environmental and social conditions.
- Today this 16 person board strives to protect the natural resources within the state.

Utah Department of Agriculture & Food

- Provides funding to UACD and the conservation districts

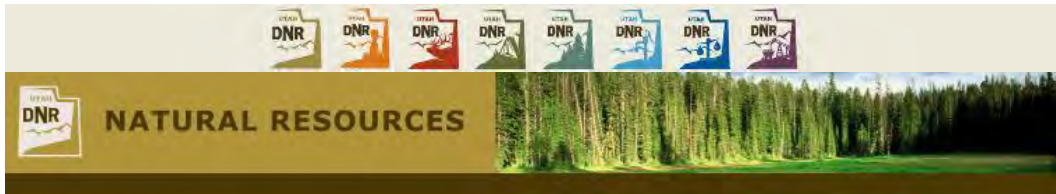
Utah Dept of Environmental Quality (DEQ)

Utah Forest Legacy Program

- Designed to protect and manage, for future generations, environmentally important forest areas that are threatened by conversion to non-forest uses.
- One method of assistance to landowners is to purchase conservation easements on a “willing seller” basis.
- A Forest Stewardship Plan (FSP) is drawn up for each property to encourage long-term stewardship of private forest land.

Working Lands Initiative

- Helps agencies and communities keep working lands working while preserving the environmental benefits.
- This is often done using conservation easements, legal agreements that restrict the type and amount of development on a property while compensating the landowner for the value such development might represent.

Partners for Fish and Wildlife

- Provides cost-share dollars to farmers and ranchers interested in increasing production while improving wildlife habitat.
- This private lands program provides funding through cost-share agreements for 10-30 years for both uplands and wetlands.
- Projects can include fencing, water development, re-establishment of riparian habitat, installation of water control structures and others.

Conservation Reserve Program (CRP)

- CRP, a federal Farm Bill program, encourages farmers to convert highly erodible cropland or other environmentally sensitive acreage to vegetative cover, such as native grasses and wildlife plantings.
- Farmers receive an annual rental payment for the term of the multi-year contract.
- Cost sharing is provided to establish the vegetative cover practices.

Continuous CRP Sign-Up

- ❑ Continuous CRP Sign-up, a federal Farm Bill program, helps landowners install conservation buffers along streams and waterways.
- ❑ Program applies to cropland as well as overgrazed, eroded pasture along streams, lakes and wetlands.
- ❑ Program offers cost-sharing for conservation practice installation and annual rental payment.

State Revolving Fund (SRF) Nonpoint Source Financial Assistance Program

- ❑ This program provides loans and/or grants for water quality improvement projects, including lakes, streams, wetlands and groundwater.
- ❑ Individuals, businesses, corporations, associations, private entities and government agencies are eligible.
- ❑ Loans are usually provided at 0% interest.
- ❑ These NPS funds can provide match for other funding sources including 319 grants, ARDL loans and other state and federal funds.

Nonpoint Source Implementation Grants

- The 319 Program provides grants to states to implement nonpoint source projects and programs in accordance with Section 319 of the Clean Water Act.
- Grants are provided to a lead agency in each state. The Utah Department of Environmental Quality administers this program and contracts for local projects through the Utah Department of Agriculture and Food, conservation districts, UACD and other entities.
- Grant awards are for up to 60% of the project cost.

Agriculture Resource Development Program

- The ARDL program is a \$27 million revolving fund that provides low interest (3%) loans for projects with a conservation benefit.
- Goal is to help landowners conserve soil and water, increase yields, maintain and improve water quality, conserve and improve wildlife habitat, prevent flooding, develop on-farm energy projects and mitigate damages caused by natural disasters.

Grazing Improvement Program (GIP)

- Provides grants to private landowners to improve range conditions and control weeds.
- The GIP program utilizes state grazing and weed boards to provide leadership to Utah's livestock industry and state and federal partners on rangeland and noxious weed issues.

Environmental Quality Incentive Program

- EQIP, a federal Farm Bill program, offers financial, educational and technical assistance to help install or implement conservation practices in 1-10 year contracts.
- Cost sharing will pay from 50-75% of the costs.

Wildlife Habitat Incentives Program

- WHIP, a federal Farm Bill program, provides financial incentives to develop habitat for fish and wildlife on private lands.
- Participants enter into a 5-10 year cost share agreement for wildlife habitat development.
- Cost sharing will pay 75% of the cost.

Ground and Surface Water Conservation

- The GSW section of the EQIP program provides cost share payments, incentive payments and loans to producers to carry out eligible activities:
 - to improve or enhance irrigation efficiencies
 - convert to production of less water-intensive agricultural commodities, such as dryland farming
 - improving water storage through water banking and groundwater recharge
- To qualify, the assistance must facilitate a conservation measure resulting in net savings in ground or surface water.

Farm & Ranch Lands Protection Program

- FRPP, a federal Farm Bill program, helps farmers and ranchers keep their land in agriculture by providing matching funds to purchase conservation easements.
- The land must contain prime, unique or other productive soil, or historical or archaeological resources, be privately owned and be large enough to sustain agricultural production.

Wetlands Reserve Program (WRP)

- ❑ WRP, a federal Farm Bill program, is a program to restore wetlands.
- ❑ Landowners can establish conservation easements of either permanent or 30 year duration or can enter into restoration cost-share agreements where no easement is involved.
- ❑ In exchange, the landowner receives a percentage of payment or cost of restoring the wetland, depending on the agreement.

PL-566 Watershed Protection Program

- This program provides cost-share funds for land treatment measures to develop and conserve soil, water, woodlands, wildlife, energy and recreation resources on the land.
- Structural measures for flood prevention, recreation facilities and water quality improvements can be implemented on a watershed basis working with local and state agencies in small watersheds.
